For the last phrase at the end of the last sentence, I suggest changing "inclusion of all people on the autism spectrum and their families" to "inclusion for all people on the autism spectrum and their families." Using the proposition, "of" could be interpreted as including all people on the autism spectrum, while using the preposition, "for," indicates that inclusion (as will as improved health, well-being, and acceptance) will occur for all people on the autism spectrum.

Naturalistic is a loaded word and challenges our communication of science-based understanding and interventions. I don't know that IACC can set terminology, but it does seem worth making this adjustment in the text (maintaining references). In addition, could eliminate "pharmacological" in the objective as these interventions are already considered as a limited section under "medical." That could enable removal of naturalistic and generally improve communication of the full range of interventions that will be considered under this objective. Consider including "occupational" after "educational."
